The Art and Science of Spiritual Direction: *A Gift to Self,*

A Journey with Another *A Promise from God*

Why is Spiritual Direction important?

Spiritual Direction is a relationship between two believers that live a radical belief in the divine gift of the Incarnation. We believe that God became human in Jesus Christ. From that belief flows consequences of faith and behavior. The first consequence is that we believe God is incarnated, enfleshed, human. Faith calls for, demands even, relationship. Our faith then must be entrusted, tested challenged, confirmed, corrected, shared, celebrated (and more) with another human being. In that sharing with another, the directee deepens membership in the community of believers. In that participation in community, the Church becomes manifest. Faith can never be so private, so personal, so emphasizing 'me and God' (the vertical) that it excludes the possibility of being shared with another (the horizontal) trusted believer. This is true for every believer, every one who desires to serve the Church in public ministry and particularly necessary for anyone seeking ordination. By freely participating in Spiritual Direction, I give myself the gift of full and active participation in the mission of the Church, the mission of Christ Himself.

What is Spiritual Direction?

Spiritual direction is a journey, a relationship between two believers; one of whom shares their faith and its manifestations in his or her life and the other who reflects that experience back through the prism of the resources, Tradition and wisdom of the Church. It is a journey directed by the Holy Spirit through the enfleshment of another.

Some images of spiritual director:

- a mirror
- an honored guest
- an astringent
- a well

- a 'marking'
 - a wisdom figure
 - a safety net
 - a respectful corrective
 - a relationship of spiritual intimacy
 - a fellow traveler or trusted companion "on the way"
- a place that can hold all of my story with reverence

What Spiritual Direction is not:

It is not counseling or therapy but may lead to that. It is not trying to look good or perfect in the eyes of another. It is not a parental relationship of unconditional love. It is not mutual. It is not social or superficial. It is not a relationship of a spouse, a peer or a sponsor while at the same time it may have elements of each. It is not a relationship of a superior to an inferior. It is not a punitive relationship or a co-dependent relationship. It is not an 'extra' that divides believers into first and second-class disciples.

Why is Spiritual Direction so important that it must be required?

Spiritual Direction is a time-honored tradition in the Church because time and again it has revealed the promise of God: "God is faithful, and by him you were called to fellowship with his Son, Jesus Christ our Lord." (1Cor.. 9) It is one part, a very important part, of an overall formation process. The goal of diaconal formation is an integrated faith in a ministerial identity. Other components that you will come to participate in (and are also required) are journaling (i.e., writing reflection papers), theological reflection, the art of discernment, and small group faith sharing.

Spiritual Direction aims at assisting growth toward maturity in faith and in the fullness of life Jesus promised. The spiritual director is primarily a listener and co-discerner. The goals for the directee include articulation, awareness, clarification and in this program, vocation discernment. It is a process and relationship that is entered into for the specific time of formation but with the hope that it will become such an important part of the deacon's life that he will want to voluntarily continue in spiritual direction after ordination. It is important for those who want to grow in prayer. It is an ongoing support in one's life in faith during a program that may challenge, through theological and scriptural in-put, long held religious ideas. The response to a vocational call to Holy Orders is so vitally important to the Church that she must walk through this path with the candidate. After all, the sacrament belongs to the Church and not to the individual.

MINUTES for Council Meeting of April 7, 2003, at Cathedral of Christ the King.

PRESENT: All, except Deacons Jindrich, O'Connor, Egan, Mure, and Heinsch.

Meeting was opened with a prayer by Deacon Mobley.

OLD BUSINESS:

- Deacon Sutter reported that Region 1 held a meeting at St. Andrew at 10:00 a.m. on Saturday, March 15, 2003, with seven of 32 members present, including two newly ordained deacons. Several consensus decisions were made. (1) Hold approximately quarterly meetings, the summer one of which would be an evening social to which spouses and deacons-in-formation who have been admitted to candidacy would be invited. (2) Provide continuing education and spiritual topics for the three quarterly business meetings, using region's own internal resources. (3) Engage in service projects and bereavement activities on the district council level. The next four meeting dates/locations/times were set. Friday evening, June 13, at 7 p.m. at St. Andrew; Saturday morning, September 20, at 10 a.m. at All Saints; Saturday morning, November 1, at 10 a.m. at St. Monica; and Saturday morning, February 21, 2004, at 10 a.m. at a parish to be decided later.
- A question was raised about how the Clergy Newsletter was disseminated at various parishes and whether there was any way to assure that deacons received copies. Consensus was that the mail distribution problem could only be corrected at the parish level. Situation may improve once new Archdiocesan web site becomes fully operational and access can be had electronically, presumably with deacons being given access.

NEW BUSINESS:

- Mike Balfour made a presentation on a Deacons' Council web site. He included in the package he left with Council members sample web sites for the USCCB and another diocese. He informed the Council that he would be responsible for content and appearance of any web site we developed, while Deacon Joe Eustace would assist the Chairman with technical aspects. Council members were asked by the Chairman and Mike for input on what information should be included in the web site and what of it should be password protected. Council members were asked to submit their comments to these two questions either before or at the next meeting. Before going operational, the Council web site will be linked to the Archdiocese web site.
- Deacon Sinanian told the Council that information on diaconate formation could be obtained from his web site (which ultimately will be linked with the Archdiocesan web site). The address for it is <http://archatl-diaconal-formation.org>.
- The Chairman discussed his presentation to the Priests' Council. The Chairman's draft report to the Council on that meeting is attached.
- After discussion, consensus was reached that revised guidelines should be drafted with respect to pastor's recommendations for admission to the diaconate formation program. Deacon Sinanian agreed to develop the initial draft of such guidelines for Council discussion and amendment.
- Deacon Womack discussed his Deacons-by-Age spreadsheet analysis. He will collate the results, along with information provided by Deacon Sinanian on deacons-in-formation for class of 2004, by Deacons' Council regions by next meeting so a decision can be made whether to redraw region boundaries to "balance" equitably the number of members-by-region.

Next meeting will be held on Monday, May 5, 2003, at 7:00 p.m., at the Cathedral in Conference Room 2.

Motion to Adjourn having been made and seconded, the Chairman concluded the meeting after Deacon Womack offered the closing prayer.

REPORT ON PRESENTATION TO THE PRIEST COUNCIL

The following is a report to the Council of Deacons of my recent presentation to the Council of Priests as discussed at our last meeting.

The presentation began with a brief overview of the formation of the Deacon's Council. Included was a description of the formation, identifying the members of the Council and a listing showing which parishes were in each region. The fact we will occasionally rearrange our regions to maintain a balance of deacons in each region was mentioned.

Following this, the plans for this year were presented: A summary follows:

- 1) We anticipate more active regional meetings which, from reports from other dioceses, should develop into the strength of the Council. Some regions are working on ways to include priests in their activities.
- 2) A general shift to include continuing education within each region is anticipated.
- 3) Efforts are underway to develop work/service projects to build community and to support the identity; of service as deacons.

Next on the presentation, as requested by the Council, was the issue of relationship between deacons and priests. The priests were requested to consider wording memos and correspondence to reflect on the use of "priest" and "clergy". We understand the need to specify "priests" on many occasions, however, it would be appreciate (sic) any consideration of using "clergy" to show when deacons are included.

The priests were requested to consider the following four items and contact me with any suggestions:

- 1) Any suggestions on how deacons would better assist priests?
- 2) Would it be worth the effort to develop a "pool" of deacons willing (with their pastor's concurrence) to assist neighboring parishes when needed?
- 3) What could be done to help priests/deacons get to know each other?
- 4) Would deanery (s) consider including a representative from the region at the deanery meeting?

Following the presentation, several questions were posed. A general discussion addressed an issue raised of some parishes having a lot of candidates for the diaconate and no anticipated need. It is understood there is a need for deacons, however, the need may not be in adjacent parishes where the candidates live. Another item addressed the

logistical problem of training candidates in remote areas and in languages where candidates do not speak English

One topic addressed is a feeling by some that some deacons recently want to focus their “service” on liturgical functions. I assured them that from my training, we are ordained to serve. (As a note, I did not preach for the first 6 or 7 years) We understood having the FACULTY to preach, baptize, etc, does not imply we have the necessary; “gifts” nor does it imply we have the permission of the pastor to use the faculties granted. We need to remember we are to use the gifts we do have to empower the lay people, to enable them to take leadership roles, then “step back” and let them function in these roles. We then move forward into new areas which can best support the pastor and bishop.

I thanked the Priests’ Council for the opportunity to bring these topics to their attention and for their support in our efforts.

MINUTES for Council Meeting of **May 5, 2003**, at Cathedral of Christ the King.

PRESENT: All, except Msgr. Reynolds and Deacons Mitchell, Robichaux, Egan, Mure, and Balfour.

Meeting was opened with a prayer by Deacon Publicover.

OLD BUSINESS:

- Deacons O'Connor, Huynh, McManus and Sutter reported on scheduled meetings for Regions 1, 3, 5, and 6. Region 1 is a summer social; the other three are business meetings with a continuing education component.
- Although Deacon Egan was absent, he sent a report that he had 12 deacons who had volunteered to develop a comprehensive procedure for bereavement situations, including materials for Pastors on deacon burial options and improved notification procedures for when Deacons Womack and Sutter are out-of-town or otherwise unavailable. (Deacon Publicover agreed to assume delegation from Deacon Sutter to act as Deacon Womack's principal "Calling Post" notification procedure back-up until the new procedures are developed).
- Dick Conti reported that the Jubilarian Mass for four deacons who have served the Archdiocese and their parishes for 25 years is scheduled for Tuesday, June 17, at Holy Cross Parish with Mass at 7:00 p.m. and reception to follow. Food service for the reception is available for either \$24 or \$15, for refreshments and a seated dinner or heavy buffet, respectively. After discussion, a consensus was reached that approximately 300 people should be anticipated to attend the reception, including jubilarian family members and invitees, priests, deacons and spouses, and others who attend the Mass. Deacon Sinanian, who is meeting with Deacon Mitchell on other matters on May 8, will ascertain from Deacon Mitchell how much money is available to underwrite reception costs, after which Deacons Robichaux, Mitchell, and Conti will take appropriate action to finalize reception arrangements.
- Consensus existed, after discussion, that Deacon Balfour should password protect all personal information as to deacons, which would be compiled for the Council's web site. General information on the diaconate would be available to the public, as well as the name and parish assignment and parish contact information, as well as possibly year of ordination. Council recommended that Deacon Balfour proceed to develop the web site along the lines he proposed at the April meeting, using his own judgment and with guidance from Council officers, reporting back to Council for final review and approval when the project was substantially completed.
- Deacon Sinanian discussed with Council proposed draft "guidelines" for Pastor recommendation of men for the diaconate formation program, as well as post-ordination diaconate assignments. He submitted the draft document to the Council Chairman for consideration and report back by the Episcopal Delegate, Director of Deacon Personnel, and the Council Chairman.
- Deacon Sinanian agreed to ascertain from Deacon Mitchell at their May 8 meeting what is the status of the draft "Deacon Policy Manual" so that it can be incorporated, if ready, in the pending new Archdiocesan Policy Manual.
- Deacon Jindrich informed the Council that Father Peter Jandaczek, M.S., has agreed to direct the October 3-5, 2003, Deacons and Wives Annual Retreat. Council gave Deacon Jindrich its thoughts concerning possible topics that would spiritually assist both deacons and wives. Deacon Jindrich will work with Father Jandaczek to develop the final retreat topic.

NEW BUSINESS:

- Deacon Womack announced that he had just disseminated electronically new deacon allocations by region based on his earlier developed data.
- Deacon Heinsch informed Council that, by next meeting, he would have proposals for a Deacons' Night at the Braves and a possible ocean cruise program with a spiritual component.
- Deacon Sutter asked Deacon Conti, when he next speaks to the Jubilarians, to ascertain whether any of them would be interested in being one of the three or four deacons assigned to Word and Altar roles for

the Eucharistic Congress. Deacon Sutter will use Deacon Conti's feedback, along with any from Council members, in participating with Master of Ceremonies Father Brian Higgins in making assignments at their May 14 meeting.

- Council members were asked by Deacon Sutter to encourage participation by deacons ***in the June 21, 2003, Eucharistic Congress at the new Georgia International Convention Center*** in both the morning Eucharistic Exposition liturgy and the evening Mass (for which at least 50 deacons are needed along with 50 priests in the sanctuary to act as ordinary ministers of Holy Communion). As many deacons as want, beyond the 50 who will be on the altar, may participate in the evening Mass procession. This Eucharistic Congress should not have any of the past traffic or seating space problems – the facility is more than twice the size of the former GICC and access and parking off Camp Creek Parkway is convenient, although bus transport by parishes is still being encouraged.
- ***Deacon Sutter encouraged Council members, and all deacons, to obtain a copy of the Archbishop's memorandum in the May 2 clergy newsletter.*** The new GIRMs (which are 131 pages in length) may be downloaded from the USCCB from <http://www.usccb.org/liturgy/index.htm>.

Next meeting will be held on Monday, **June 2, 2003**, at 7:00 p.m., at the Cathedral in Conference Room 2.

Motion to Adjourn having been made and seconded, the Vice-Chairman concluded the meeting after Deacon Jindrich offered the closing prayer.
